These help materialized the Visions GOD has given us in the form of: <u>TEMPORARY/VIRTUAL OFFICES</u> since 2004 to the present; <u>HMF</u> HUMANITARIAN PROFILE BOOKS that depicts how HMF is going to operate globally, HMF Doctrine, HMF Constitution and By-Laws, etc.; BOOKS on The Proposed HUMANITARIAN **COLLABORATIVE AGREEMENTS (HCA)** for participating organizations and different governments, etc.; VIDEOS and BROCHURES to introduce HMF; VIDEOS and BROCHURES of Roadmaps to Participation by Collaborating Organizations and the different Governments; VIDEOS of different PROGRAMS and PROJECTS to be implemented globally; FOLDERS, **LETTERHEADS, CALLING CARDS** and thousands of **LETTERS & POSTAGE** to bring awareness of HMF's Programs and existence; different INVITATIONS, PROGRAMS, STREAMERS, FOOD & **DRINKS** to serve whenever we do HMF PRESENTATIONS to introduce HMF, to prepare the projects and find our co-leaders in the different cities here in California (2004-2013), Korea (2001-2004) and the Philippines (1996-2009).
